Central panel slams T'gana dam, KCR's party hits back

The report blamed lack of stringent quality control during construction

he BRS government in Telangana has come under heavy criticism along with allegations of corruption after a report of the National Dam Safety Authority blamed a combination of issues involving planning, design, quality control and operation and maintenance of the Kaleshwaram Lift Irrigation Scheme (KLIS) for the cracks in the piers of the Medigadda barrage. KLIS is the flagship project of the BRS government and has become a key issue ahead of the Assembly elections in this month

According to the report "The primary reason for the failure is the settlement of the barrage raft. The piers, being monolith with it, have also settled, moved and cracked. This could occur due to several possible reasons that is, piping wherein transportation of foundation



material has occurred, inadequate bearing capacity of foundation material (sand), failure of upstream secant piles due to barrage load."

The report also blamed lack of stringent quality control during construction and also in its design and planning. "The barrage has been designed as a floating structure but constructed as a rigid structure," it read adding that inspection and maintenance of the dam have not

been done since its commissioning in 2019-2020. It further said "The barrage under the present condition is rendered useless unless fully rehabilitated." Under the circumstances the report recommended against the filling of the barrage.

SC to hear TN plea against T'gana polls: AIMIM fields RSS flag marches on 6 Nov



The Supreme Court on Friday listed for 6 November the Tamil Nadu government's plea challenging Madurai bench of Madras High Court permitting Rashtriya Swayamsevak Sangh (RSS) to conduct flag marches in the state.

A Bench of Justice Surya Kant and Justice Dipankar Datta ordered the listing of the matter on 6 November, following a mentioning of the plea by the senior advocate Kapil Sibal assisted by advocate Sabarish Subramanian. The Tamil Nadu govern-

ment moved the Supreme Court against the 18 October 2023 state High Court order allowing RSS to conduct flag marches in different parts of the state. The state government contended that the high court, while allowing the marches by the RSS, did not consider the history of violent incidents and their needs and objects. It said the court did not factor in the intelligence reports on the possible occurrence of incidents affecting the law-and-order situation, completely ignoring the other religious congregations during the ongoing Navratri festival and Thevar Jayanti across Tamil Nadu. The Tamil Nadu government's petition says that the respondents are representatives of the organisation named Rashtriya Swayamsevak Sangh which is neither a citizen of India and nor a corporate body and thus is not vested with the fundamental right guaranteed under Article 19 of the Constitution which is available only to the citizens.

The petition reads: "That the Respondents without any
